## DIRECTIONS FOR USE

### RESTRAINTS

DO NOT apply as a space spray.

DO NOT apply to mattress or bedding.

PEST	CRITICAL COMMENTS
Cockroaches, ants, mosquitoes, flies, confused flour beetles, house crickets, web-spinning spiders	Apply as a surface application up to but not exceeding the point of run off onto surfaces and into cracks and crevices where insects are likely to rest, harbour, live and breed for up to 3 months residual control. Use crack and crevice nozzle to direct spray into cracks, crevices and other hard to reach places. PHANTOM can also be applied directly as a spot treatment to live insects.
Saw-tooth grain beetles, bed bugs, pill bugs (slaters), Indian meal moth.	Apply directly as a spot treatment to live insects. An IPM approach should be followed for the control of bed bugs. For more information refer to the Code of Practice for the control of bed bug infestations in Australia.

## GENERAL INSTRUCTIONS

### APPLICATION

This product is ideally suited to be used with the System III Pressurised dispenser unit. If using without System III, hold container upright whilst spraying. After use with the System III Pressurised Dispenser, ensure that the valve is closed and that the hose line is drained to avoid leaking.

PHANTOM® PRESSURISED INSECTICIDE is non repellent to some species of insects and is suitable for use in integrated pest management and will not prevent feeding on baits such as GOLIATH and AMDRO. PHANTOM is not a synthetic pyrethroid and can be used to control insect pests in internal and external situations in and around domestic, commercial and public buildings: including food processing facilities, hospitals and schools. Spray from a distance of 20-30 cm directly onto insects or spray onto surfaces for residual protection as per the Directions for Use table. Phantom will control insects within a few days of application. Apply Phantom to clean surfaces, free of dirt, dust, oils, grease and other residues. Surfaces should have a small hidden area sprayed and checked for any discoloration before widespread use. Applications in food handling establishments must be limited to crack and crevice treatments. The food handling area must not be in use during application. Clean food contact surfaces thoroughly before processing/serving resumes.

For insecticide resistance management, PHANTOM® is a Group 13 insecticide. Some naturally occurring insect biotypes resistant to PHANTOM® and other Group 13 insecticides may exist through normal genetic variability in any insect population. The resistant individuals can eventually dominate the insect population if PHANTOM® or other Group 13 insecticides are used repeatedly. The effectiveness of PHANTOM® on resistant individuals could be significantly reduced. Since occurrence of resistant individuals is difficult to detect prior to use, BASF Australia Ltd accepts no liability for any losses that may result from the failure of PHANTOM® to control resistant insects.
